1. Edit Scope of Work Assurance Area D School Year 2 Evaluation Systems:

Under Scope of Work Activities (Evaluation):

Changed #1 to read: We are piloting OTES evaluation system without student growth measure in two buildings in the district

Modified #2 to read: We are piloting OPES evaluation system without student growth measure Added #3 to read: Develop comprehensive models for teacher and principal evaluations, including timelines, activities, and personnel, with the goal of full implementation of new evaluation system by 2013-2014.

<u>Under LEA Annual Performance Measure Targets (Evaluation):</u>

Changed #1 to read: By June 2012, a teacher and principal from both Hardin Central and Kenton High School will attend all state required training sessions for the pilot program.

Changed #2 to read: By June 30, 2012 Kenton City School Board will adopt a Board Resolution to adopt a principal evaluation system that meets ODE standards.

Added #3 to read: If selected, Kenton City Schools will participate in the OTES pilot.

2. Discuss "My Voice" to determine our involvement:

Decision needs to be made in February about My Voice or Care Team Perception Survey Care Team survey is already paid for through Care Team grant

Care Team gives us the data, then our teams are on their own to run the process My Voice provides some support, but there may be a cost after the initial year

More research is needed on the results of the My Voice vs Care Team survey to determine if the results are there for changes that actually occurred in school climate as a result of the implementation of these programs

Jodi will research My Voice, Jen will research Care Team, Julie will look into a notebook from Ada Schools

Information will be presented at the DLT meetings, which should be shared with BLTs, who will then share with the staff
