### 2. Will May PD delay support our incomplete year 2 goals?

June 27, 28, 29 Connect for success, Espy is sending a team of 7 teachers re: teacher based teams & assessment

KHS will have staff who went to task design share out in May at the 2-hour delay what they have done this year with project based learning.

### 3. Mary's explanation of work needing accomplished on student growth measures, list of approved assessments, and student learning objective information.

Mary talked about state tests at the high school- eventually there will be a traditional AND performance based assessment.

IIS will be free to districts through July of 2015, training will be paid by RttT, districts will have to cover the cost of subs & travel

The first IIS pilot should start March 2013

Cost for IIS will be per student in the future

Mary explained the SGM components Document

If it is on the ODE approved vendor list, we must use it as evaluative if used by the district  
Remind teachers that the data is measured over 3 years time.

Mary explained the Steps for Designing a Local Student Growth Measure Plan

When the OGT goes away, it won't be replaced with another huge test

Kenton should benchmark against other HS's for end our course exams.

Break teachers into categories, those with VA scores, those without, those with data on the ODE approved list.

The IIS will have an "item creation ability" for districts to use as an LEA

#### 4. May 7th Regional Meeting Agenda and SOW Revision Protocol Reviewed

Print out SOW on your own

RttT coordinator will get copies of: budget, revisions document, and PD plan for workshop

We need to focus on developing a plan for the next 2 years re: teacher & principal evaluation systems.

Suggested we pilot this with volunteers next year, collect feedback about the values of each & design a tool that takes the best of both. Also, pilot student growth measures.

We need to start with the 7 teaching standards when beginning to explain the process to teachers.

#### 5. Begin Discussion on Revision of year 3 SOW incorporating our PD plan

We discussed these items:

1. By June 2013, 50% or more of our curricula will be aligned with state standards and have associated learning goals and targets. Yes we can do this.
2. By June 2013, 50% or more of staff will participate in sessions to share any formative assessments designed to align to new state standards. Yes we can do this.
3. By June 2013, 100% of our kindergarten teachers participate in training on the administration of the newly expanded version of the state's Kindergarten Readiness Assessment. Yes.

By June 2013, 100% of reading and mathematics teachers in grades 4-8 participated in professional learning in the use of value-added data and other measures, the use of IIS systems and formative instruction practices to continually inform improving learning.

1. \* Mary suggested we change this to: By June 2013, 100% of teachers giving new state assessments complete training\*as it becomes available\*
2. By June 2013, 75% or more of our math staff rate the SMI (Scholastic Math Inventory) MCP(math coach) providing support to our LEA as effective or highly effective on a survey. Mary suggested we strike thru this or adjust after June data is released.
3. By June 2013, at least 75% of teachers will actively use the approved IIS at the classroom-level to inform instruction. Mary suggested that we leave this alone too.
